General Policies

Regional Exclusivity Policies

Regional Exclusivity is dependent on clients giving us correct information regarding the shows they will attend. We want you be the only band @ any festival you attend, playing the show you have rented. Please provide a list of potential shows you will attend in 2025. If you are part of a competitive circuit be clear what class and what championships you might attend. We cannot be held responsible for incorrect or incomplete information. Digital File Policies

Finale files and .xml Files are available for your use. All files must be destroyed November of 2025. You may not share music files with anyone outside your staff. Sharing files outside your staff will be considered a copyright violation.

Show name Policy

You may change the name of any rented show to meet your show ideas.

Customization Policies - Rewrites are done on a limited basis.

Send very specific details of any edits you want. Please use bar numbers with specific requests. We need to get your edits requests ASAP. Edits can take up to 4-5 weeks depending on the time of year. Requests made in early spring usually take two weeks. We may not be available in August/September for revisions due to scheduling demand. General Editing Policies:

Any alterations to a show such as transitions, low brass part reductions, re-titling, or anything else requires custom work. Please note that even simple "cuts" require a healthy amount of work especially if you factor in cleaning the music (separating collisions of various markings or revising the new rehearsal marks) as well as extracting and reformatting the new parts.

When we provide custom edits, you receive the following:

- New PDF parts (if altered-only altered parts) New PDF scores
- New XML file (This file works with all notation software) New Finale or Sibelius File
- New mp3 (midi recording, might be missing some percussion and synth audio, will not have EFX)

Time listed for customization in each package includes all unique work on your project.

Please send a list of customization needs and we can give you an estimate of the amount of time needed to complete your requests.

Additional customization beyond your package is @ \$100 per hour

Changing bass drum line size does NOT count towards edit time - Free service!

You will be notified and given a quote before we start to charge you additional fees
